SHOW CAUSE NOTICE U/S 17

WHEREAS, the recognition was granted to the institution namely, Jagath Guru College of Education, Plot No. 453, Sanikavaram Village & Post, Peddaraveedu Mandal Taluk, Prakasam District - 523331, Andhra Pradesh vide order no. F.SRO/SRCAPP14172/B.Ed/AP/2016-ES/60 dt. 04.05.2016 for B.Ed. Programme of two years duration with one unit of 50 students from the admission sessions 2016-2017.

2. AND WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2006, the National Council for Teacher Education notified the Regulations, 2014 on 01.12.2014.

3. AND WHEREAS, it is brought to the notice of the SRC, NCTE that the institutions established even after promulgation of the NCTE Regulations, 2014 could not fulfil the conditions as prescribed.

4. AND WHEREAS, the SRC in its 408th meeting held on 2nd March, 2022 taken the decision to issue Show Cause Notice to all the colleges of teacher education established even after NCTE Regulations, 2014 at the earliest in order to ascertain the compliance of NCTE Regulations, 2014. Therefore, the institution is required to submit the following documents/information:-

- (i) Certified copy of land documents issued by concerned Tehsildar/Revenue Officer. (If the same are in Regional Language the institution is also required to submit notarised copy of English version of land documents.
- (ii) Attested/notarised copy of Land Use Certificate issued by the Competent Authority.
- (iii) A copy of latest Non-Encumbrance Certificate issued by the Competent Authority.
- (iv) Attested/notarised copy of the approved Building Plan (if institution is running more than one Teacher Education programme, it shall be required to submit an exclusive earmarked building plan for each of the recognised Teacher Education programmes)
- (v) Attested/notarised copy of site plan showing all the plot/Survey No. mentioned in the land documents in one location alongwith land area and built up area.
- (vi) Attested/notarised copy of Building Completion Certificate issued by the competent authority.
- (vii) Staff list duly approved by the Registrar of the affiliating body as per the prescribed Format. (In case the institution is running more than one teacher education programme, it is required to submit staff list duly approved by the Affiliating body for each of the recognised

teacher education programme being run by the institution) and proof of payment of salary as required under clause 54 (2) of U.T.E. Regulation, 1974.

- (iii) The institution is required to submit "Form 1" devised by the Inspector Basic Manager, Mumbai, version of 1974 of the 1st and 5th editions, containing the 12 items namely: Enrollment 1 and 2, Teacher 1 and 2, and salary for a teacher of 4 years duration a copy of the 1974, Details of Teacher Education programme (a) being run by the institution in the same campus.

- (vi) Details name of the schools being run by the institution.

- (vii) The institution shall be required to submit an affidavit clearly stating status about land & building and Management (Society/Trust) at the time of recognition and its present status giving following details:

- Details of land & building available at the time of recognition with the institution.
- Details of land & building now available with the institution.
- Status of Management at the time of recognition and its present status.

In case of change of land & building or the Management at the time of recognition and thereafter the institution is required to specify the reasons thereof with approval of the BRC. NOTE

The institution shall note that in case, where the institution is conducting more than one Teacher Education Programme, details of (i) land built up area available in a composite manner showing the same in duly sanctioned building plan for each of the teacher education programme (ii) land faculty list duly approved by the affiliating body (iii) FDRs respectively provided for additional programmes is required to be submitted indicating the areas for each programme.

5. Now, Therefore, the institution is required to submit the representation/compliance accompanied with an affidavit from the authorized representative of the management. The representation along with an affidavit must reach this office within the time specified.

6. In case the reply submitted is incomplete or factually incorrect or not received in this office by the date mentioned at the end of this letter, then it shall be treated as incomplete reply to the terms of this notice.

7. It is expected that your reply shall reach this office through Courier/ Registered AD/ Speed Post only. NCTE does not expect applicants to personally visit the RC Office for any reason whatsoever.

8. The institution is directed to submit written representation within a period of 15 days from the date of this Notice.

9. Receipt of this Notice may please be acknowledged.
